Delisting as a Part of the Decay of Information in the Digital Age: A Critical Evaluation of *Google Spain* (C-131/12) and the Right to Delist it has Created 149

In the *Google Spain* case, the Court of Justice created a substantive right for EU citizens to have search results relating to them delisted. Citizens can invoke this right if the links in question provide access to personal information about them, which is no longer adequate or relevant or has otherwise become excessive. This article critically analyses the Court's reasoning and the right to delist that was created. It particularly aims to highlight potential implementation issues and proposes some alternative ways forward.
